Capital Projects Fund

- The Commonwealth of Massachusetts ("the Commonwealth) has made \$145 million in Capital Projects Funds ("CPF") available to the Broadband Infrastructure Gap Networks Grant Program ("Gap Networks Grant Program" or the "Program"), to address the critical digital needs of towns and cities, with a particular focus on communities with substantial low-income households and disadvantaged populations.
- The Program is funding the deployment of broadband infrastructure in areas that currently lack access to sufficient broadband internet service, defined as service offering download speeds of at least 100 Mbps and upload speeds of at least 20 Mbps.
- The federal requirements for the ARPA Capital Projects Fund are different than the federal requirements for the Broadband Equity, Access and Deployment (BEAD) Program under the Bipartisan Infrastructure Law.
- MBI has administered Round One and has launched Round Two of the Gap Networks Grant Program. This process will end before MBI administers the subgrantree selection process under BEAD.



Eligible Entities

- **Private entities**
 - Which includes corporations, limited liability companies, general partnerships, limited partnerships, etc.
- **Local governmental entities**
 - Which includes municipalities or municipal light plants that offer broadband service
- **Tribal governments**
- Non-profit organizations
- Co-operatives, electric co-operatives, and utilities
- **Public Private Partnerships**
 - Which are long-term agreements between local government entities and private entities for the delivery and funding of broadband services
- Other entities that develop and/or operate broadband networks
 - Which are entities that can demonstrate the experience, capacity and financial resources and stability to satisfy the grant obligations



Eligible Projects

- **Last Mile** is broadband infrastructure that serves as the final leg connecting the internet service provider's network to the end-user customer's on-premises telecommunications equipment.
- Middle Mile is high-capacity broadband infrastructure that connects disparate communities to the internet backbone, is not intended to connect directly to large numbers of end-user locations and enables interconnecting disparate internet service provider infrastructure to last mile broadband services of at least 100 megabits per second download and 100 megabits per second upload and is scalable to higher speeds.
- Note: Applicants must demonstrate that Middle Mile is necessary to facilitate Last Mile connections (cannot exceed 25% of total project cost)

Eligible | Projects



Project Service Areas (PSAs)

- A Project Service Area ("PSA") refers to a specific geographical region encompassing a single municipality where the Applicant proposes to provide broadband services. PSAs also referred to as ("Projects") can include BSLs on both public and private lands. Applicants must commit to serving all Unserved and Underserved BSLs in each PSA.
- Applicants are only allowed to include one municipality in each PSA or Project.
- There is no limit to the number of PSAs that each grant application can include. Each proposed PSA will be evaluated separately and, if awarded, each PSA will have their own scope of work.
- The grant applications must include a letter of support from the governing body of each municipality corresponding to the PSA that will be served by the proposed project. The municipal letter of support may be satisfied by a letter supporting the Applicant's project signed by the chief executive or administrative officer of the municipality, including a Town Manager, Town Administrator, City Manager or Mayor. Failure to include a letter of support from the governing body in the application will disqualify the PSA from consideration.

02B Eligible | Locations



Eligible Locations

- <u>Unserved Locations</u> are BSLs without access to broadband internet speeds of at least 25 Mbps download and 3 Mbps upload.
- <u>Underserved Locations</u> are BSLs without access to broadband internet speeds of at least 100 Mbps download and 20 Mbps upload.
- Maps:
 - In defining the project service area(s),
 Applicants are encouraged to review the FCC's
 National Broadband Map
 (https://broadbandmap.fcc.gov/home).

Broadband Serviceable Locations: BSLs are premises that include one or more residence or business where fixed broadband internet access service is or could be installed.

BSL Eligibility List: A list of all BSLs that are presumptively eligible for funding in Round 2 are available for download from the solicitation page: (https://masstech.org/broadband-infrastructure-gapnetworks-grant-program).

Projects must include all eligible BSLs from the BSL Eligibility List for the proposed municipalities.

BSL Reconciliation: Award recipients will have the opportunity work collaboratively with MBI to modify the final Project BSL list prior to contract execution. Modifications may include the following:

- Adding eligible BSLs to the Project that are missing from the BSL Eligibility List,
- Adding community anchor institutions that were not on the BSL Eligibility List
- Removing BSLs from Project that do not meet program guidelines

02B Ineligible | Locations



Ineligible Locations

- Locations that are not broadband serviceable locations (with the exception of community anchor institutions)
- Served locations (access meets or exceed 100/20)
- Locations that have already subject to a binding funding commitment from federal or state sources such as:
 - Broadband infrastructure grant programs administered by EOED, including Last Mile Infrastructure Grant Program
 - Broadband infrastructure grant programs administered by MBI, including Flexible Grant, Broadband Extensions, and PPP Grant programs
 - Programs administered by NTIA, including Broadband Infrastructure, Tribal Broadband Connectivity Program, and Middle Mile Broadband Infrastructure programs
 - Programs administered by FCC, including RDOF and Enhanced-ACAM
 - Programs administered by USDA, including Reconnect, Community Connect, Telecommunications Loans, and Farm Bill programs



Gap Networks Grant Program



Eligible Technologies

- Must meet or exceed 100Mbps symmetrical speed requirement
- Preferred technologies are:
 - Fiber networks, and
 - Hybrid fiber-coaxial networks
- Fixed wireless technology will be considered on a case-by-case basis

02B Eligible | Costs



4.5.1 Eligible Costs

- Make ready
- Design and engineering
- Permitting and regulatory compliance
- Network equipment, fiber/cabling, facilities and materials
- Construction and installation
- Qualifying Long Drop, Non-Standard Customer Installation costs
- Qualifying Overbuild costs
- Facility leases > 1 year, including IRUs and capital leases
- Personnel costs
- Costs to comply with monitoring and reporting requirements



02B Ineligible | Costs



4.5.2 Ineligible Costs

- Acquisition of spectrum licenses
- Operating expenses
- Short-term operation leases
- Payment of interest or principal on outstanding debt instruments
- Fees associated with issuance of new debt
- Satisfaction of any settlement agreement, judgment, consent decree, judicially confirmed debt restructuring plan, etc.
- Support or opposition of collective bargaining
- Program grant application preparation costs
- Expenses incurred prior to grant agreement execution

02C PRIORITY PROJECTS

Qualified Census Tracts

A Qualified Census Tract (QCT) is defined as an area where at least 50% of households have an income that is below 60% of the local Area Median Gross Income ("AMGI") or where the rate of poverty is 25% or higher.

Gateway Municipalities

A Gateway municipality is a municipality with a population greater than 35,000 and less than 250,000 with a median household income below the Commonwealth's average and a rate of educational attainment of a bachelor's degree or above that is below the commonwealth's average.

02D Alternative Construction Types | Overbuilds



Overbuilds

- MBI will consider overbuilds only if:
 - The overbuild is incidental to accomplishing the overall objectives of the Program
 - *The overbuild is* the most cost-effective method of reaching the targeted Unserved and Underserved locations in the Project Service Area.
 - The Served and Unserved/Underserved locations within the PSA are clearly distinguished
 - Costs associated with an Overbuild are fully funded by the Applicant's Funding Match

Alternative Construction Types | Long Drops



Long Drops

- Applicants may request funding to cover the cost of a "non-standard" customer installation that requires the customer to contribute to the upfront, non-recurring cost of the installation. These are costs other than standard connection fees charged to all customers.
- Applicant will cover standard installation portion of drop at its own cost
- Eligibility is limited to unserved and underserved locations in a Project Service Area
- Grant subsidy is capped at \$10,000 per location

Match Funding Contributions

- Mandatory minimum Funding Match of 20% of total project costs
- Funding Match up to the minimum of 20% must be the Applicant's own source and cash funded.
- In-kind contributions cannot be counted toward match requirement
- Funding Match amounts that exceed 20% will receive additional points during the evaluation and may be externally sourced.

Waivers

- Waivers of Funding Match requirement are only available for municipalities with outstanding debt obligations remaining from broadband infrastructure projects that will have broadband coverage gaps addressed by the proposed project.
- Debt must be incurred prior to submission of grant application

02F THRESHOLD CRITERIA

Threshold Criteria

- 1. Did the Applicant complete section 3 of the Application General Information?
- 2. Did the Applicant (i) complete and submit Section 4 of the Application Project Service Area Overview; and (ii) upload all required attachments, including required supporting documentation?
- 3. Did the Applicant (i) complete and submit Section 5.1 of the Application Support of Target Populations and Equity; and (ii) upload all required attachments, including required supporting documentation?
- 4. Did the Applicant (i) complete Section 5.2 of the Application Applicant's Ability to Execute the Project; (ii) upload all required attachments, including required supporting documentation?
- 5. Did the Applicant (i) complete and upload Section 5.3 of the Application Project Feasibility and Reasonableness; and (ii) upload all required attachments, including required supporting documentation?
- 6. Did the Applicant (i) complete Section 5.4 of the Application Technological Approach; and (ii) upload all required attachments, including all required supporting documentation?

Grant Terms and Conditions



- The Funding Agreement will include terms and conditions including, but not limited to:
 - Description of the services
 - Roles and responsibilities
 - Grant payment schedule (payment on a reimbursement basis upon completion of milestones)
 - Eligible uses of funds
 - Period of performance
 - Accounting and reporting requirements
 - Compliance requirements
 - Remedies for noncompliance
 - Audit practices
 - Recording keeping
 - Internal controls, and
 - Other terms required by federal law



Confidentiality



- All responses, applications, data, materials, information, and documentation submitted in response to the Gap Networks Program shall become MBI's property and shall be subject to public disclosure.
- MassTech/MBI is public entity and is subject to the Massachusetts Public Records
 Law. Every document submitted to MassTech/MBI is a public record unless an
 exemption applies.
- If an Applicant wishes to have MassTech treat certain information or documentation as confidential, the Applicant must submit a written request to MassTech's General Counsel prior to submission to MassTech/MBI. The details for this process are in Section 7.2 of the grant solicitation.

Overview of Application

 (https://masstech.org/broadband-infrastructure-gap-networks-grant-program)
- The online grant application for Round 2 went live on May 23, 2024
- Online grant application structure:
 - General information about the Applicant and a high-level summary of the Application will be submitted through the online application.
 - Information that is required for each proposed Project Service Area is submitted through three fillable PDF forms and up to twelve spreadsheet templates.
 - The links to the PDF forms and spreadsheet templates are embedded in the online application. Links to each of these documents are also posted on the Gap Networks program page on the MBI website.
- The online application has the ability to save your progress, as long as the same computer and browser is used for each session.
